

A wider policy network with a globally-relevant, continental perspective AfCFTA Policy Network (APN) is a membership-based organisation dedicated to working with relevant stakeholders, such as Ministry of Trade & Industry, Ghana and AU's Department of Trade & Industry to help implement AfCFTA.





APN has an awareness-creation mandate that includes holding Media Symposia (maiden one was in October 2019). It also possesses an MoU with Association of African Universities TV,

where APN, through the Deputy Executive Director, currently hosts Agenda2063 TV Show, which is a weekly show on AAUTV channels that seeks to shed light on AfCFTA and developments around Agenda 2063.

In October 2019, APN held the maiden edition of its Media Symposia to help Ghanaian media and international media better-understand the AfCFTA and how it would work once trading began.



Since January 2020, APN has been hosting Agenda 2063 TV show, which is the only show in Ghana ; West Africa ; and the continent seeking to unpack developments around the AU ; its institutions, including AfCFTA.

APN Management has formed relevant networks both online and offline of key actors within AfCfTA landscape; and the organisation holds regular sessions with the network using dedicated whatsapp platforms, which are digital extensions of its thematic work.

This includes ; APN Plenary (that brings together membership) ; Women of Africa Network (populated by women that are members of the subsidiary of APN) ; Afcfta International Stakeholders' Forum (populated largely by participants who attended n AU Consultative & Sensitization Meeting on AfCFTA and Private Sector in Dakar, Senegal in November 2018) ; and AfCFTA Peace & Security Stakeholder's Network, which is populated by peace and security practitioners, and migration governance experts, and staff members of International Organisation for Migration (IOM).

APN management holds occasional webinars, with the one in February, entitled "AfCFTA Rules of Origin for Exporters and Importers, Traders, Private Sector and Entrepreneurs with the Rules of Origin Experts". It was held in association with Bank of Africa.



Since August 2021, APN has been working with the IOM on dedicated advocacy to help popularize the AU's Freedom of Movement Protocol (AU FMP)

APN prosecuted a very successful communication strategy to support the maiden edition of the



Africa Private Sector Summit, which is a new, tripartite initiative to bring private sector and academia together with public sector and right the wrongs of doing business under AfCFTA (#RightingBizWrongs). APN will continue to play a key role in the six other series.
